## 2011 – 2012 INTERNATIONAL AGENT CONTRACT

This document enters New Hope Christian Schools into an agreement with \_\_\_\_\_ (herein referred to as agent). The agent agrees to search for and supply international students to attend New Hope Christian Schools, which is located in Grants Pass, Oregon. The agent also agrees to communicate and relay messages and school documentation to the student's parents. Said agent understands that this is NOT an exclusive contract and that the school partners with other international agents. The school agrees that they will never allow a student, once affiliated with your agency, to return on their own or through another agency to this school, unless the previous agent no longer services secondary Christian schools .

Tuition and fees for the 2011-2012 school year is \$15,000 for International Students (IS), with a minimum \$7,500 due by August 15<sup>th</sup> and the remainder by December 15<sup>th</sup>. Add a late fee of \$250 if not paid by these dates. International students may NOT begin school without the tuition and fees having been received by our Bank. New Hope Christian Schools agrees to pay up to \$1,500 commission to the above named agent for each international student who enrolls and attends its school for a full year (as a result of the agent's efforts). If \$15,000 is paid up front, agent is authorized to deduct their full \$1,500 agent fee from the said tuition payment. The agent also understands that once the school year has begun, if a student transfers or returns home for any reason other than death or an emergency medical condition, the tuition for that particular semester is non-refundable, unless death or emergency medical condition arises. An additional \$400 may be deducted from the \$15,000 if tuition and fees for a "returning" International student are received by July 1<sup>st</sup> of said year student is enrolling at New Hope Christian School.

**Deposit of the non-refundable application fee of \$250 must be received for issuance of a new or modified I-20.** This application fee applies toward the school's previously stated tuition and fees. Effective with 2008-2009 school year, IS Memory/Yearbooks were instituted and are available for review and purchase for approximately \$50 each for students and/or agents.

Effective for the 2012-2013 school year, the application fee will be a separate entity from the annual IS Tuition and Fees of \$15,000.
